## Information clause for Fellowship Holder

According to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (EU Official Journal L 119 of 4 May 2016) - hereinafter referred to as GDPR - and Article 14(1) and (2) of the GDPR, we inform you that:
