

# Have You Seen It? Promotion Regulations

## §1.

### General Provisions

1. The Promotion is organised by the International Cultural Centre with its seat in Krakow (31-008), at Rynek Główny 25, entered in the RiK register under the number - 2/92, using the NIP number 6751000104 (hereinafter referred to as the “Organiser”).
2. Taking part in the Promotion will be tantamount to accepting the Regulations.
3. The Regulations are available at the Organiser's seat and on the Organiser's official website ([www.mck.krakow.pl](http://www.mck.krakow.pl)).
4. All information regarding the Promotion can be found on the website: <https://mck.krakow.pl/program-lojalnoscowy-2>. Any changes and modifications to the Regulations of the Promotion will be posted by the Organiser on the above-mentioned website.

6. The Promotion starts on July 22, 2022 and will last until November 6, 2022.

## §2.

### Promotion objectives

The Promotion is organised with the objective to:

- promote the knowledge related to the exhibitions “Homing. Włodzimierz Puchalski” and “In Ukraine. Justyna Mielnikiewicz”,
- develop artistic sensitivity;
- increase the audience's participation in the Organiser's educational events.

## §3.

### Participants

1. Promotion Participants are defined as all those taking part in the Promotional programme.
2. Participation in the Promotion is completely voluntary.
3. To participate in the Promotion the Participants are required to collect a Participant Card, hereinafter referred to as “the Card”, at the ICC Gallery.
4. All costs related to the participation in the Promotion shall be borne by the Participant.

## §4.

### Participating in the Promotion

1. Participation in the Promotion consists in collecting stamps on the Card.
2. The Card with the first stamp can be obtained for the purchase of an admission ticket to the exhibition “Homing. Włodzimierz Puchalski” or “In Ukraine. Justyna Mielnikiewicz” or the participation in screening programme “Cinema on the roof of the ICC. Naturally”.
3. After receiving the Card, the Participant should sign it with his or her name and surname.
4. A stamp can be obtained for the participation in the events accompanying the exhibition “Homing. Włodzimierz Puchalski” or “In Ukraine. Justyna Mielnikiewicz”:
  - a) meetings organised at Organiser’s seat;
  - b) guided tours of the exhibitions “Homing. Włodzimierz Puchalski” and “In Ukraine. Justyna Mielnikiewicz”;
  - c) the film screening series “Cinema on the Roof. Naturally” (you can get one stamp for each screening);
  - d) city walks organised by the Organiser;  
and for buying an entry ticket to “Homing. Włodzimierz Puchalski” or “In Ukraine. Justyna Mielnikiewicz”.
5. The promotion does not include online events.

## §5.

### Prizes

1. For collecting six stamps on one Card the Participant will receive a free entry ticket to the exhibition of Małgorzata Mirga-Tas at the International Cultural Centre Gallery, Rynek Główny 25.
2. The Card can be exchanged for an entry ticket in the ticket office of the International Cultural Centre Gallery, Rynek Główny 25 (1st floor) during the Gallery’s opening hours.

## §6.

### Final Provisions

2. All content contained in the advertising and promotional materials is for information purposes only. Only the provisions of the Regulations have legal force.
3. The Organiser reserves the right to amend the Regulations. The Regulations may be changed, to the extent that does not infringe the rights of the Promotion Participants, by publishing its new content on the website. Amendments to the Regulations may be introduced and announced no later than 14 days prior to their introduction.

4. The International Cultural Centre, Rynek Główny 25, 31-008 Krakow is defined as the founder of the prizes and guarantor of the prizes within the meaning of Art. 919, 920 and 921 of the Act of April 23, 1964 - Civil Code (Journal of Laws of 1964 No. 16, item 93, as amended).
5. The Participant may resign from participation in the Promotion at any time of its duration.
6. In matters not covered by the Regulations, the provisions of the Civil Code and the Act on Copyright and Related Rights shall apply.
